For value received herein, part of which is the understanding that as the responsible table holder at this AMCA Show, the receipt of which is hereby acknowledged, I, hereby knowingly, intentionally and voluntarily waive, release from liability, indemnify and agree to hold harmless the activities of all parties to wit; The Alabama Military Collectors Association, Inc., also recognized as AMCA and AMCA, Inc., the Huntsville Jaycee's and the City of Huntsville, their directors, officers, employees, members, or agents who "is or was" serving at the request of the corporation / city as a director, officer, employee, member, agent, sponsor or facilitator, from any and all liability resulting from seen and unforeseen acts, which include natural disasters, e.g., "Acts of God", i.e., COVID-19, and all variants. Additionally, all liability which may result from the sale, damages, actions, causes of action, suites, injuries, and costs of attorney's fees of the released parties which may result from my participation in this AMCA Military Collectors Show.
